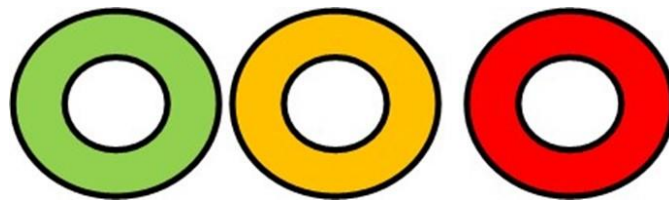


My Personal Information, and My Equality and Diversity Portlets

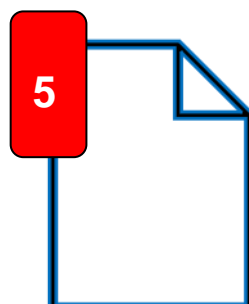
